CHECK-IN PROCEDURES

We understand how important dropping your child off at camp is. We want to help relieve the anxiety of drop off and make the process flow as seamlessly as possible. In order to make the first day easy, we require all balances and paperwork be turned in to our office no later than **June 1st**. The required paperwork (medical recommendation, health history, day camp permission and day camper profile) can be accessed through your online account.

WHEN ARRIVING

The front gate will be open from 8:55 am to 9:30 am. Please park in the parking lot just inside the gate and walk your camper to the pavilion. Since resident camp will be going on at the same time, we will not allow cars or parents to enter past the parking lot. If you are running late please contact the Day Camp Director to make arrangements. After you've signed your daughter in, checked the announcement board for daily announcements and told her goodbye, you will have completed the check-in process and are free to leave. On the first day of camp, please bring any necessary medication and discuss special medical instructions or concerns with the Day Camp Director.



IN ORDER TO CHECK OUT, YOU (OR ANY AUTHORIZED PICK-UP PERSON) MUST HAVE A PHOTO ID

All authorized persons must be listed on your online RRR account (www.rockyriverranch.com)

Pick up will be from 4:00 am to 4:30 pm. Please park in the parking lot and check your daughter out at the pavilion with a photo ID. If you need to pick up your camper earlier than 4:00, please contact the Day Camp Director to make arrangements.

All sessions will end on Friday at 12:00 with an opportunity for parents to interact with the RRR staff and enjoy a short closing ceremony. Day campers and their parents will be done before the closing ceremony for resident camp which begins at 1:30. In order to manage congestion and traffic flow, we ask that all day camp families are out of the parking lot by 1:00.

OTHER PROCEDURES

CAMP PHOTOS

During the session, camp staff will take each teach your child to be camper's photo and a group photo of the entire day camp session. A 5x7 group photo will be given be involved in labeling to you at check-out for no charge. Purchase of your camper's individual photo is optional and can be done through your account at www. rockyriverranch.com. We will also upload snapshots of activities during each session – these may be purchased as well. Once purchased, you can download the images and print them at home. Packing an inexpensive disposable camera or inexpensive digital camera is another way to allow your camper to record her own special memories of camp.

LOST & FOUND

Camp life strives to responsible for and take care of her belongings. It helps for your camper to and packing her own bag for the day so she will be aware that they belong to her if they show up in the Lost & Found.

Please label all items with your child's name. We will make every attempt to reunite lost items with the rightful owner before each day ends. If items are left at camp, please contact us and describe (in detail) the missing item.

Items not claimed by September 1st will be donated to a local women's shelter.

REFUND POLICY

Cancellations received in writing by our office prior to June 1st will receive a full refund (minus the nonrefundable deposit). Cancellations after June 1st are not eligible for refunds.

CANTEEN

Campers enjoy canteen time each day after free swim, where they can choose an ice cream, candy or snack item. Your camper's canteen account is included in camp tuition and you will not need to pay for these snacks. Campers are not allowed to keep cash at camp.

ONLINE STORE/CARE PACKAGES

Our online store allows you to purchase items such as t-shirts. stuffed animals and other RRR souvenirs. You may have items mailed home or delivered at camp. Items delivered at camp will be distributed at the end of the camp day.

HEALTH INFORMATION

CAMP NURSE ON SITE

Our camp nurse is on site at all times and is available for medical needs. She will administer medication, attend to minor injuries and overall camper health care. We like to collect camper health information ahead of time so that we are prepared for any medical needs.

There are two medical forms required:

(1) Health History Form

This form can be completed online via your RRR account. Just log-in, click on Document Center (under Additional Options menu) and complete the information for each camper. This form must be completed by **June 1st.**

(2) Medical Recommendation Form

This form must be downloaded, printed, completed by your doctor's office and returned to the RRR office. In the Document Center of your online account (under Additional Options menu), you will find the Medical Recommendation Form, located on the right-hand side. This form can be mailed, faxed, uploaded or emailed back to the RRR office and must be received 2 weeks prior to your camper's check-in day.

MEDICATIONS

Since the day camp day is short, we prefer morning and evening medicines to be administered at home. If a prescription medication MUST be administered between the hours of 9-4, please let us know by entering these medications on your online account. Click on your camper's name from the account detail page. On the lower left you will see a "Manage" button under medications. Please enter the name and dosage for each medication. This info can be edited on your account until 1 week prior to your session. Please email if any changes occur after this time.

WHEN ARRIVING THE FIRST DAY:

Please meet with the Day Camp Director if your child needs medication to be administered by the camp nurse. Note that all medications <u>must be</u> <u>in the original bottle</u> <u>or container from</u> <u>the pharmacy. We do</u> <u>not accept expired</u> <u>prescriptions.</u>

By state law, the nurse will not distribute medications that are not in the original containers. Prescriptions must have the camper's name and dosing instructions on the label. Please check that the instructions you leave match the doctor's dosage. The information will be entered in the nurse's ledger to ensure that the meds are given to your camper as required. The online forms also serve as permission to treat your camper in the event of an emergency.

MEDICAL TREATMENT

Our camp nurse or director will notify parents if a camper exhibits symptoms that are deemed worthy of concern.

Please do not send your child to camp if she is running a fever or is in poor health. We try to provide the safest and healthiest environment for all campers. In an effort to keep everyone in good health, we ask that vou consult a doctor before bringing your child to camp if she has recently suffered from or been exposed to an illness. We also ask that you check your child for head lice several times in the weeks leading up to camp.



FREQUENTLY ASKED QUESTIONS

I HAVE ANOTHER DAUGHTER WHO IS ATTENDING RESIDENT CAMP DURING THE SAME SESSION. HOW WILL DROP OFF AND PICK UP WORK?

Drop off will be on separate days which will provide you a chance to focus on each daughter's check-in separately. Pick-up on Friday will be on the same day during Day Camp Session 1, 3 and 4. During those days, please arrive at 12 to participate in the closing activity for Day Camp. You will then need to wait until Closing Day activities for Resident Camp to begin at 1:30. You are welcome to stick around the pavilion. chatting with your camper or you can drive into Wimberley and come back in time for the resident camp closing at 1:30.

WILL THE DAY CAMPERS AND RESIDENT CAMPERS SEE EACH OTHER DURING THE DAY?

Day campers and resident campers will have separate schedules during the day, however, they will get to see each other during canteen time! This will be a chance to eat a snack, play games together and mingle!

WILL COUNSELORS APPLY SUNSCREEN AND BUG REPELLENT FOR MY CHILD?

YES! Our well trained staff are very cautious about sunburns and bug bites. We are very dedicated to making sure your child stays safe and healthy and will help them apply sunscreen and bug spray throughout the day.

WHAT WILL MY DAUGHTER DO WITH ALL OF HER STUFF DURING THE DAY?

Each camper will have a cubby where she can store her belongings- lunch, towel, swim suit, extra change of clothes etc.

HOW WILL SWIMMING WORK DURING THE DAY? WHAT IF MY CHILD IS NOT A STRONG SWIMMER YET?

During the first day of Day Camp, we will have a swim check for your daughter. The swim check will be held by the lifeguards and will give them an idea of your daughters swimming ability. We will have life vests for girls who need/ want them. We will also have a rope in the pool to separate the shallow end and the deep end. We will have multiple lifeguards at the river and at the pool. Our lifeguards are all Red Cross certified.

CAN I VISIT MY CAMPER WHILE SHE'S AT CAMP?

For the safety of all of our campers, Rocky River does not allow visitors on the campsite while camp is in session. Parents are only allowed in the parking/ pavilion area between 8:55-9:30 and 4:00-4:30. Parents may not go past the cone markers at any time during the camp sessions.



FREQUENTLY ASKED QUESTIONS

WHAT HAPPENS IF MY **CAMPER GETS SICK AT** CAMP?

Rocky River takes health care very seriously. Our wellness center is well equipped, staffed and maintained for our campers who need special care, and our camp nurse is on-call throughout the season. Our counselors are trained in CPR and First Aid. Should any concerning health issue arise, a staff member will contact the parents right away.

HOW WILL LUNCH WORK EACH DAY?

Please pack a lunch for your daughter each day. The day campers will eat at picnic tables at the pavilion with their counselors. We will provide snacks and ice water throughout the day.

WHAT IF I NEED TO **DROP OFF LATE OR PICK UP EARLY ONE** DAY?

IS THERE A DRESS CODE?

The campers will be very active throughout the day so we encourage the girls to wear comfortable clothing that they don't mind getting messy in. We will be taking a group picture on the first day so please have your camper wear the RRR Day Camp shirt. The girls are required to wear shoes that deposit until **June 1st**. will stay on their feet (no flip flops) and they will also cancellation in writing so need to wear river shoes when they go to the river.

WILL THERE BE THEME DAYS FOR MY **DAUGHTER TO PARTICIPATE IN?**

YES! We will have Wacky Wednesday during each session. We encourage campers to participate in this by wearing wacky clothes, socks, hats, hair styles or anything else that is WACKY!

WILL MY DAUGHTER **DRAW TO SEE WHAT CAMP TEAM SHE WILL BE ON?**

Day campers will not draw to be on a team. Teams will only be drawn during resident camp sessions. Something to look forward to!
